I agree to assume full responsibility and guardianship of _____. I agree to provide all medical care including an annual exam, all vaccination and monthly preventatives for heartworms and fleas/ticks stated above.

I agree to provide a proper living condition which includes but is not limited to a safe environment for living, nutritional food, clean water, a proper amount of exercise and maintaining the physical condition. I agree that this dog will remain an indoor family pet for the duration of their life. I agree to treat this animal ethically and humanely for the entirety of their life. Should any medical conditions arise that are cause for concern, I agree to take _____ to the vet immediately, without question.

I agree to keep all required tags and identification on my dog/puppy at all times. Should said dog or puppy escape or get loose, I agree to notify Rescue for Love immediately for assistance. I will make every effort to recover and search for said dog/puppy, which includes but it not limited to putting up fliers, calling and notifying police and shelters, placing ads in local newspapers and searching actively for him or her.

I agree that _____ will not be used for anything other than a pet living in my home. I agree that under no conditions will this dog be left in dangerous conditions that may jeopardize their health or well being.

I agree that I filled out the application with all answers truthful and forthcoming. I agree that I read and understand the policies that were attached to the application when I filled it out. I acknowledge that the policies were agreed to when I submitted the application.

I acknowledge that should any behavioral issues or concerns should arise, that I will seek help from a professional trainer or behaviorist for assistance, lessons or training prior to surrendering back to Rescue for Love. I agree to make every effort to correct behavior issues with assistance if needed. I agree that should I have to move from my home, I will make every effort to find housing that allows said dog/puppy to live with me. In addition, due to circumstances and only after I have made every attempt to resolve any problems, should I not be able to provide a home for this pet, I agree to contact Rescue for Love and not surrender to any other person, shelter or rescue.

I agree to spay or neuter the animal if it has not been done prior to adoption. I agree to be diligent with regards to insuring that no breeding will take place should said dog or puppy not be spayed or neutered prior to adoption. Should a litter result from not spaying, Rescue for Love reserves the right to take possession of the full litter and parent, therefore voiding the adoption agreement. In addition, should the dog/puppy not be micro-chipped, upon his or her first examination or spay/neuter, he/she will be micro-chipped and I will notify Rescue for Love of the micro-chip number for their records. I understand that Rescue for Love will not consider the adoption complete until vetting/micro-chipping has been done.

All dogs and puppies are required to have a vet visit within a set time.

* Dogs and puppies need to be seen by your vet within 30 days of adoption for a wellness visit.

There is NO exception to this policy and no special considerations will be given. We will provide all the medical information for the puppy or dog to take to the vet prior to the appointment, but it will be your vet who will determine vaccination updates, micro-chipping costs and medical needs including the appointment time for the spay or neuter if required. Should I cancel my appointment or change my vet for any reason, I will contact Rescue for Love with this information.

I agree that Rescue for Love can do a follow up in my home after the adoption is complete and give Rescue for Love permission to follow up with my veterinarian about the care that is being provided.

I agree to hold, Rescue for Love and all members associated with Rescue for Love, under no liability for damages, incidences, lawsuits, judgments or any other financial responsibility for the dog or actions taken once ownership is transferred. I agree to take full financial and physical responsibility for this dog. This agreement is a binding legal contract and once signed is fully in effect. A copy of this agreement will be mailed to you. Any breach of this contract can result in Rescue for Love reclaiming ownership of said dog or puppy. I agree to pay all cost necessary to enforce this contract, including all attorney fees and all costs of litigation if contract is breached.

I acknowledge that all information that I have provided is true and honest. I agree that should I provide any false information, this contract is null and void.

Each page must be signed and dated by adopter. Please take a moment to make sure you have signed and dated each page at the bottom prior to filling out the last page acknowledging that you have read and understand each page of this contract.
