I accept full responsibility for actions of said foster while in my care. I will hold Rescue for Love harmless of losses, accidents, property damage, injuries to human or other animals, financial responsibilities while in my care outside of stipulated medical or agreed upon additional costs. I acknowledge that incidences can occur and am fully prepared to take that responsibility.

I agree to keep the said foster free of harm and to keep proper registration tags attached to a permanent collar that is to stay affixed at all times to said foster. I agree that said foster will not be allowed off their leash unless in an enclosed/fenced supervised area. I accept responsibility for walking the said foster safely and with caution.

Rescue for Love will provide medical treatment, leash, collar, bowl for food or water if needed, crate if needed and a bed if needed. As a foster, I am expected to provide constant care and provide a lifestyle that will be conducive for re-homing the foster. We encourage crate training, socializing, leash walking, and teaching of proper indoor manners. All items purchased for fostering by Rescue for Love will remain the property of Rescue for Love and will be returned upon request.

I agree to notify Kristi Blassberg # 914.582.7242 or Robert Blassberg #914.582.2467 immediately of any and all incidences that require medical assistance or in any emergency and prior to taking said foster for any medical care. Any items purchased by a foster home will be at fosters expense, unless otherwise agreed upon by Kristi or Robert Blassberg.

I give Rescue for Love permission to do a home visit and to come to check on said foster at any given time. I agree not to leave said foster in any boarding or kenneling facility without prior consent from Kristi Blassberg, Founder of Rescue for Love. I agree not to leave said foster in the care of anyone additional without prior consent from Kristi Blassberg, Founder of Rescue for Love. I agree never to leave said foster crated more than 6 hours at a time, preferably 4 hours or less unless at night time.

I acknowledge this is a legal and binding agreement between myself and Rescue for Love. I agree to honor all stipulations and conditions set forth in this contract and to foster ethically and with respect for Rescue for Love.
